Payment Options

ACH draft - Monthly dues and fees drafted from your checking/savings account on the 15th of each month. If you'd like to utilize ACH payment, please complete the ACH information below.

Credit card on file - Monthly dues and fees automatically charged on the 15th of each month to the credit card or debit card provided by Member on the attached Authorization Form. Credit card charges will be subject to a 3.5% processing fee.

Cash, Check or Credit Card - Members who don't elect a monthly payment automatic deduction option must pay quarterly dues and fees by check, cash or credit card via mail or at the pro shop in the first 30 days of the quarter. Credit card charges will be subject to a 3.5% processing fee. Quarterly dues received after 30 days will be subject to a \$25.00 late payment fee.
